

# Ripley County Commissioners Meeting

## October 04, 2021

### Pledge of Allegiance

**Roll Call:** Mark Horstman, President, Chris Schmaltz, Kendall Hankins, Amy Copeland, Auditor & John Ertel, County Attorney.

### Maintenance – Becky Cairns in place of Craig Herbert

Mrs. Cairns stated that Mr. Herbert has been working on the courthouse flooring. Jeff Poole from the Poole Group, Inc. gave an update on what he has seen in the courthouse with the flooring. The Poole Group, Inc. quote is for \$460.00 to tear up the floor and see what is wrong with it.

**Motion:** Commissioner Hankins made the motion to approve the quote to look at the circuit court floor with a price of \$460.00, **Action:** Approve, **Moved by** Kendall Hankins, **Seconded by** Chris Schmaltz. Motion passed unanimously.

### Technology – Becky Cairns

Ms. Cairns stated that Ms. Ginger Bradford, Clerk, is needing a new copier/printer in the election room. Ms. Cairns has tried to get ahold of the company that did the economic development website. She is working on quotes for a new website.

### Sheriff – Bob Curl

Mr. Curl stated they had a problem with the walk-in-freezer. Mr. Curl stated that Dunlap mentioned that the walk-in-freezer needs replaced. Dunlap has a quote for a new freezer for \$8,600.00. Commissioner Horstman asked for a second quote. Commissioner Hankins stated we need to get it fixed right away.

### EMS – Scott Huffman

Commissioner Horstman stated that we had a finance committee meeting and talked with Mr. Poole from the Poole Group, Inc. Mr. Poole got up and spoke with the commissioners about the EMS remodel.

Mr. Huffman stated that we are no longer going to cover Dearborn County unless it is mutual aid, but we do not have the staff to take a primary call.

Mr. Huffman stated that they received \$20,000.00 from Rising Sun Regional Foundation. The quote was for \$55,000.00 for a new roof, siding, gutters, downspouts, and windows.

### Johnson/Melloh Solutions – Rick Anderson

Mr. Anderson brought in a request for proposal. Commissioners are wanting to wait at least a month, to see what happens with the flooring issue.

**Public Discussion – Tasha Shelton**

Ms. Shelton address is 3388 N CR 600 E, Milan, IN 47031 about a noise ordinance for the county. She has had a lot of problems with the neighbors and the base of their music. Ms. Shelton has called dispatch numerous times to help. Attorney John Ertel stated that you can file a complaint in Area Planning for a noise ordinance.
