The Ripley County Council met on Monday, March 18, 2019 at the Ripley County Annex in Versailles, Indiana. Council President Brenda Wetzler opened the meeting with the Pledge of Allegiance to the flag. Council Members Ron Decker, Lucinda Dunbar, Steven Gloyd, Rob Seig, David Tebbing, and Brenda Wetzler were in attendance as well as Auditor Amy Copeland and County Attorney John Ertel. Note:	Council Member Seig made the motion to approve the above appropriation for EMA, Council Member Gloyd 2nd the motion. Motion passed 6 yes.

The Council's recommendation on this was to advertise with a pay range from \$36,455 to \$40,455. If there are applicants with the experience then an additional appropriation will need to be done.
